Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. 2022-23 School Safety Plan

Coleman F. Brown Elementary School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of our staff and the School Site Council. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. The school staff suggested final changes and had input on new assignments at the 8/26/2022 staff meeting. The Site Council is comprised of teachers, classified staff, parents, and the principal. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian.
